



10th Ang Mo Kio CC WEC All Women Chess Challenge 2024

- 1) **Organisers:** Ang Mo Kio CC Women’s Executive Committee and played under FIDE Laws of Chess and the following rules and regulations, and held in collaboration with Chess Academy (Singapore) Pte Ltd. The Open and Challengers Category are FIDE Rated.
- 2) **Date & Time:** 14th April 2024 Sunday – 9.30 am to 6.00 pm.
- 3) **Venue:** Ang Mo Kio CC multi-Purpose Hall. 795 Ang Mo Kio Avenue 1 Singapore 569976
- 4) **Category:** (a) **OPEN** (FIDE Rated – No Age Restrictions). Must have FIDE ID.
 (b) **CHALLENGERS** (FIDE Rated – No Age Restrictions). FIDE ID.
 (c) **UNDER 8** (Born 2016 and after)
- 5) **Entry Fee:** \$ 40.00 (Players in Open & Challengers Category with FIDE ID)
 \$ 30.00 (Participants in Under 8 Category – Born 2016 after)
- 6) **Payment:** Payment shall be via **PayNow** to our Chess Academy (Singapore) Pte Ltd - DBS Account - UEN – **201105374E**. Please indicate player’s name in your payment advice.
- 7) **Mode of Competition:** 7 Rounds using Swiss Manager with 25 minutes for each player to complete the game.
- 8) **Prizes:** Trophies shall be presented to the top 10 in each category (**Open, Challengers and Under 8**). In the **Under 8 Category**, there shall also be category prizes for Pre-School participants. In the Challengers Category, there shall be category prizes for Under 12 and Under 10. All other participants shall receive Achievement Trophies.
- 9) In the **Open Category**, **Cash Prizes** shall be presented to the 8 winners as follows -
 1st - \$ 200.00; 2nd - \$ 180.00; 3rd - \$ 120.00; 4th - 5th - \$ 80.00 each and 6th to 8th - \$ 50.00 each.
 In the **Challengers Category**, **Cash Prizes** shall awarded to the top 8 as follows -
 1st - \$ 120.00; 2nd - \$ 100.00; 3rd - \$ 80.00; 4th – 5th - \$ 60.00 and 6th – 8th - \$ 40.00 each
- 10) **Closing Date:** Monday 8th April 2024 at 7.00 pm or subject to the first 150 entries received, whichever is earlier.
- 11) In the event of any disputes, the Organizer’s and chief arbiter’s decision shall be FINAL and no further correspondences shall be entertained.
